

## Terms & Conditions

The following Terms & Conditions includes information on how to enter and the prize/s. Participation in this promotion is deemed as acceptance of these Terms and Conditions.

1. The promoter is Riverina Oils (ABN 25 103 697 703) of 177 Trahairs Road, Bomen, Wagga Wagga, NSW, 2650 (**Promoter**).
