# RIVERINA OILS Harvest Guide 2022



#### Dear Growers,

Riverina Oils will coordinate harvest receivals this year. Our priority is to deliver a fast and efficient turnaround at our receival sites.

Note, we will receive CSO1-A Non-GM seed ONLY.

**Site Operations** 

This season, we have three tipping points:

- Direct into the seed receival pit
- 2 bunkers fed by the Grain Guzzler
- Shepherds Siding (singles, truck and dog or smaller access only)

All deliveries to the main plant to arrive & queue via Gate 3.

You will be directed to the quickest tipping point at the time of arrival.

The sites will operate extended harvest hours as required. Our silos will receive Non-GM seed 24/7 - please provide notice if you plan to deliver after hours as there is limited capacity each night. On arrival to site, please enter at Gate 3 and assemble in truck parking bay; contact the weighbridge on UHF channel 20.

Shepards Siding hours 7am-8pm.

In order to facilitate efficient receivals, please make sure drivers show up with the following information:

- Vendor declaration
- Vendor decs can be completed per contract, or per paddock for cash & WHS deliveries. Please complete before arrival to prevent hold ups.
- Contract details
- NGR card
- Variety information

We are accredited by the NSW Government Grain Harvest Management Scheme (GHMS), which will allow for slight tolerance in weights during the harvest period.

Do not deliver to Shepherds Siding unless specified.

#### **NGR Details**

Please ensure your NGR details are up to date. If you have made any recent changes, contact NGR on 1800 556 630 to update your details.

We will pay the nominated bank account and we can only send contract information and RCTI's to the email registered with NGR.



# Marketing

Payment terms are 14 days end of week (EOW).

Normal AOF bonification scales are in place; quality standards are linked below.

Prices will be distributed via email and SMS; please get in contact if you need to be added to the daily distribution lists.

There are 3 marketing options at Riverina Oils this year:

- <u>Forward contract:</u> deliver against existing contracts or new contracts. Please present NGR card, contract number and vendor dec on arrival.
- <u>Cash at silo:</u> take the cash price of the day. Cash & contract price will be the same as per the daily bidsheet. NGR card & vendor dec required.
- Warehouse: NGR card & vendor dec required on delivery. Storage is FREE until September 30th, 2023. From October 1st, 2023, storage fees are \$3.50/mt/month. Additional fees only apply should you wish to outload your canola. See linked S&H agreement below for more info.

# **Safety**

Deliveries to Riverina Oils will require the below minimum PPE:

- · High visibility clothing
- Hard hat
- Safety work boots
- a UHF channel 20

If the appropriate PPE is not worn, you must remain inside your vehicle at all times.

During the COVID 19 crisis Riverina Oils has remained committed to doing what is required within our workplaces to stop the spread of COVID-19.

To ensure we can meet our ongoing obligations and provide a safe workplace for all employees, all transport providers must ensure they are not showing symptoms of COVID-19 and are unwell prior to entering any Riverina Oils site.
